It has a Board of Directors, Presidents in Countries with many members, Ambassadors, Commissions, highly qualified and seal entitled "Hypnosis Master Trainer, WHO", cooperation with accredited Universities, WHO-IN-ICI World Congresses, and qualified professional members in more than 60 countries worldwide.

The Vision

The WHO stands for using Hypnosis:

1. for contributing to a peaceful world where everybody wants to belong to
2. for excellent communication inside people in the sense of inner peace of mind, self-actualisation and living one's potential
3. for excellent communication between people for mutual understanding and highest results in reaching goals that are good for everybody on planet earth

2. for bridging effective practical application of Hypnosis with academic education, theory and research

6. "Hypnosis Master Trainer, WHO" (seal entitled, fee required)

The WHO has 3 levels of "Hypnosis Master Trainer, WHO".

1. Head of an "Experienced WHO Member Institute"
2. "Hypnosis Master Trainer, WHO" in cooperation with an "Experienced WHO Member Institute" who supports her/him during her/his first Hypnosis standard trainings
3. "Hypnosis Master Trainer, WHO" as additional trainer at an "Experienced WHO Member Institute" with the right to seal in the name of this Institute under the responsibility of the Institutes leader.

A "Hypnosis Master Trainer, WHO" has as prerequisite for his appointment at least 1.050 hours of Hypnosis training experience. A Head of an experienced WHO Member Institute at least 1.830 hours. For more details please see the website of the WHO:

7. Members on all other Hypnosis qualification levels (free of charge)

The WHO has the following levels of Hypnosis qualifications:

"Hypnosis Technician, WHO": 30 hrs/4 days

"Hypnosis Practitioner, WHO": 90 hrs/12 days (incl. "Hypnosis Technician, WHO")

"Hypnosis Coach, WHO": 120 hrs/16 days

"Hypnosis Master, WHO": 180 hrs/24 days (incl. "Hypnosis Practitioner, WHO")

"Hypnosis Trainer, WHO": 315 hrs/42 days (incl. "Hypnosis Master, WHO")
